#### WHAT IS THE INTEGRATED LAND AND RESOURCE REGISTRY (ILRR)?

The ILRR provides a web based single legal register of all rights and interests on Crown land plus information on private land, and related land use and base map information.

The ILRR is now available to government users and to industry (with BCeID accounts) and the general public (limited access).

### USE THE ILRR TO...

- Access comprehensive, current and accurate legal rights and interests information for land and resources in minutes, instead of days or weeks.
- Determine the current status of the land (Crown Land base and partial private land information).
- Identify if further historical research may be necessary, then use ILRR information to locate history in systems such as the Land and Resource Data Warehouse, and BC OnLine (land titles, personal property registries, etc.).
- Identify potential land use conflicts.
- Support:
  - land planning and treaty negotiations;
  - inter-agency referral processes;
  - o applications for interests in land, and
  - emergency planning and response.
- Faster, more consistent decision making using common information.
- Reduced risk in decision making.
- Quickly generate queries, maps or reports.

#### **WORKING IN PARTNERSHIP**

The ILRR is a collaborative project built in partnership with 21 different provincial rights granting agencies, and with input from federal, provincial and municipal government representatives, industry leaders, professional associations and non-government organizations.

Provincial rights granting agencies will be working with the ILRR on data quality improvements until 2008. In 2004/05 and 2005/06 data improvements to both the interest layers and the survey fabric took place in the northeast and south portions of BC. As a result, these areas have better quality data which supports greater functionality (e.g. search by legal description) than is available in the rest of the province.
